The Ridgeville Town Council met with all members present, Eric Huffman, Randy Young, Hunter Kisgen and Randy Green were all present. Wes Schemenaur and Nick Wells were absent. Minutes approved, Tom motioned, motion accepted by Jeff, 2nd by Bill, motion carried. Tom motioned to accept claims, motion accepted by Bill, 2nd by Jeff, motion carried.

First on the agenda was the Cheeseman property. Tom Motioned to Table, motion accepted by Jeff, 2nd by Bill, motion carried.

The grant contingency was next on the agenda. Kevin Green stated the mower and surge protection are being pushed through. Tom wants a resolution within 30 days or we are contacting the Attorney General. Kevin stated he will send an email in that regards to all parties. Tom motioned for the 30 Day Resolution, motion accepted by Bill, 2nd by Jeff, motion carried.

Our utility truck is in. We need to see about decals for the truck and a plow.

Half of the payment for the digital sign has been paid for. Toni is waiting on Lori Overmyer to get back to her with a training date. Jeff is supposed to check with the Library about their sign to make sure they are okay with that being removed.

Payroll Direct Deposit - a ticket has been created from Boyce. Toni is just waiting on them to contact her regarding next steps.

Online Bill pay (for water utility) - card reader has been received. They will be contacting Toni to schedule training.

Jonathan Snyder's water bill - Tom would like him to come to the next council meeting to discuss payment arrangements. He would like to discuss with Wes first what our options are and would like to have an Executive Session with Wes to discuss this prior to our next meeting and a few other items (water meter/usage ordinance, grant contingency, etc).

At the last council meeting, Wes suggested we contact a CPA to review our tax situation due to the notices we keep receiving. Bollenbacher and Associates from Portland has been hired.

Eric Huffman was overpaid on payroll on a couple of occasions from the previous clerk. It was brought to her attention but never fixed. Eric said he would just use comp hours to correct this. Tom motioned to allow to offset with comp hours, Bill accepted, 2nd by Jeff, motion carried.

Eric said that the PD is in need of new Body Cams. Tom motioned to allow Eric to get these body cams from the opioid fund, Bill accepted, 2nd by Jeff, motion carried.

Indiana DEA Training is scheduled for next week. Eric, Nick Wells and Steve Satterfield are all scheduled to go.

Eric asked that the board reconsider PERF. Tom said Eric needs to get some numbers together and get them to them to look at.

Eric said the PD needs new vests. No decisions were made.

Randy said the storm damage from February 5, fried the Skata alarm system, the modem and the router. The total cost is not enough to turn into insurance. Tom motioned to purchase new Skata from the Riverboat fund, Bill accepted, 2nd by Jeff, motion carried.

Randy also brought a quote for a Champion pump for Vine Street. It was also suggested to purchase two back up pumps out the contingency money. Council decided to table the purchase of back up pumps. Tom motioned to buy one pump, Bill accepted, 2nd by Jeff, motion carried.

Town Wide Clean Up dates book fast so we wanted to get something scheduled immediately. Board voted for Saturday, June 21. Tom motioned, Jeff accepted, 2nd by Bill, motion carried.
